

Discount Drug Mart's Ultimate Fan Experience Sweepstakes Official Rules

- (1) No purchase necessary. A purchase will not increase your chances of winning.
- (2) Sweepstakes open to residents who reside within a 75 mile radius of Quicken Loans Arena and who are 18 years of age or older, except employees and immediate families (spouse, parents, siblings, and children) of Discount Drug Mart, Cavaliers Operating Company, LLC (the Cleveland Cavaliers), Quicken Loans Arena, and the National Basketball Association and its Member Teams, NBA Properties, Inc., (all together herein after the "NBA Entities") and each of their respective parents, subsidiaries, affiliates, directors, officers, owners, employees and agents (collectively, the "Released Parties").

Entry must be completely filled out to be considered eligible. Two (2) winners will be chosen randomly from all eligible entries by a Cavaliers representative and will be notified by phone on April 10, 2015. In the event the winners cannot be contacted or declines the prize another individual will be randomly selected from the eligible entries.
