DIRECTIONS AND MAP

COMING FROM 71 NORTH OR SOUTH:

TAKE 18 WEST (WHICH IS EXIT NUMBER 218) DOWN APPROX 3 ½ TO 4 MILES. FOLLOW 18 WEST AROUND MEDINA SQUARE. A MILE PAST THE SQUARE ON THE LEFT YOU WILL SEE A "STOP-N-GO" TRUCK STOP. TAKE THE FIRST LEFT AFTER THE TRUCK STOP-THAT WILL BE BRANCH ROAD. GO DOWN 1 MILE AND YOUR FIRST LEFT WILL BE COMMERCE DRIVE. AFTER YOU MAKE A LEFT ON COMMERCE, WE ARE THE FIRST BUILDING ON THE RIGHT. THE FIRST TWO DRIVES ARE FOR SHIPPING. THE THIRD DRIVE IS FOR THE CORPORATE OFFICE, AND THE FOURTH DRIVE IS RECEIVING.

COMING FROM 224/76:

TAKE ROUTE 3 NORTH ABOUT 3 ½ MILES TO 162 WEST. TAKE 162 APPROX 2 MILES TO THE FOUR WAY STOP AT LAKE ROAD. MAKE A RIGHT ON LAKE. TAKE LAKE ROAD DOWN UNTIL IT DEAD ENDS INTO SMITH ROAD. MAKE A LEFT ON SMITH. THE FIRST RIGHT YOU COME TO WILL BE COMMERCE DRIVE. MAKE A RIGHT ON COMMERCE AND DISCOUNT DRUG MART IS THE LAST BUILDING ON THE LEFT. RECEIVING WILL BE THE FIRST DRIVE, CORPORATE OFFICE WILL BE THE SECOND DRIVE AND SHIPPING WILL BE THE THIRD AND FOURTH DRIVES.

COMING FROM 18 WEST:

TAKE 18 EAST TO THE TOWN OF MALLET CREEK. AT THE LIGHT (WHICH IS COLUMBIA ROAD) MAKE A RIGHT. YOU WILL GO DOWN A FEW MILES AND AROUND A COUPLE OF CURVES. THE FIRST LEFT AFTER THE CURVES WILL BE BRANCH ROAD. MAKE A LEFT ON BRANCH AND TAKE IT DOWN APPROX 1 MILE. THE FIRST RIGHT WILL BE COMMERCE DRIVE. DISCOUNT DRUG MART IS THE FIRST BUILDING ON THE RIGHT. SHIPPING IS THE FIRST TWO DRIVES, CORPORATE OFFICES ARE IN THE THIRD DRIVE, AND RECEIVING IS THE FOURTH DRIVE.
